IN SUMMER 2010, DSOP BEGAN TO REACH OUT TO CURRENT AND POTENTIAL MEMBERS VIA PHONE BANKS AND MEMBER SURVEYS. IN TOTAL, THERE ARE APPROXIMATELY 20 ACTIVE MEMBERS IN DSOP.
