THE MARBLE COLLECTION ("TMC") PUBLISHES "THE MARBLE COLLECTION MASSACHUSETTS HIGH SCHOOL MAGAZINE OF THE ARTS" THIS IS A BIENNIAL PRINT AND DIGITAL MAGAZINE WHICH FEATURES MASSACHUSETTS SECONDARY STUDENTS' ART, LITERATURE, MUSIC, AND VIDEO WORKS FIRST PUBLISHED IN SPRING 2009, THE MAGAZINE'S PARTICIPANTS HAVE GROWN FROM 24 MASSACHUSETTS SECONDARY SCHOOLS TO OVER 165 IN JUST 3 YEARS THE MASSACHUSETTS HIGH SCHOOL COMMUNITY RESPONDED TO THIS PUBLICATION WITH AN OUTPURING OF SUPPORT, CONFIRMING THAT THIS VENUE FILLS A LONG IGNORED VOID IN THE CREATIVE SECTOR SERVING AS AN EXCLUSIVE CONDUIT FOR MASSACHUSETTS' PROMISING YOUNG AUTHORS AND ARTISTS, TMC EXPOSES STUDENTS TO THE WORK OF THEIR PEERS AT THE STATE LEVEL, DRIVING STUDENTS TO WORK HARDER AT THEIR CRAFT, WHILE STRENGTHENING THEIR RESUMES, COLLEGE APPLICATIONS, AND PORTFOLIOS
