The Marble Collection: Massachusetts High School Magazine of the Arts is the only statewide, biannual print and digital magazine of the arts for and by Massachusetts teens, showcasing their art, literature, music, and video works. First published in spring 2009, this magazine's participants have exploded from 24 Massachusetts secondary schools to 175. This unique program develops and celebrates the artistic endeavors of Massachusetts secondary students, including those with limited access to arts education programming. Since its inception in 2008, TMC has published 9 print and digital editions of the Massachusetts High School Magazine of the Arts; distributed nearly 7,000 complimentary copies; hosted 59 college-level service learners; showcased over 400 inspiring student works; and mentored 325 student authors and artists through the comprehensive publication process.

4b Student-Mentoring Workshop [SMW] The SMW is an out-of-school time online mentoring program, in which teens learn to share their voice, refine their talent and gain the skills and knowledge needed to succeed under the guidance of college-level mentors. Published students are paired one-to-one with a college-level mentor, who will guide them through the stages of publication and provide valuable advice on their work. Through a series of six conversations, students discuss their art or writing professionally and their goals concerning college and the creative arts industries. During this process, students also promote themselves as professional artists and writers by learning how to craft an artist's statement and press release.

4c Service-learning Program TMC conducts a Service-learning Program in which college students learn to both manage the organization and deliver services to our high school clients. Through a comprehensive online teaching and learning model, TMC integrates meaningful community service with instruction and reflection, enriching the learning experience; teaching civic responsibility; and advancing the organization's mission. At present, TMC collaborates with a number of college and university career services across Massachusetts to recruit, train and host its service-learner staff. TMC Service-learners assume front-line positions including, but not limited to: Accounting Manager, Communications Specialist, Advertising Development, High School Mentor, among other vital roles.
