Massachusetts High School Magazine of the Arts: The Marble Collection: Massachusetts High School Magazine of the Arts is the only statewide, semiannual print and digital magazine of the arts for and by Massachusetts teens, showcasing their original art, literature, music, and video works. First published in spring 2009, the magazine's participants have exploded from 24 Massachusetts schools to 180. This unique program develops and celebrates the artistic endeavors of Massachusetts students, including those with limited access to arts education programming. All published works are juror-selected to ensure artistic excellence. Through this selective process, TMC strives to publish the most diverse and celebrated collection of work.

Student Mentoring Workshop [SMW]: TMC offers teens a semiannual online Student Mentoring Workshop [SMW] in which they are paired one-to-one with college student Service-Learners who help them refine their voices and guide their work to publication for real-world audiences. The SMW aims to improve teens' artistic craft and knowledge of the professional publishing process, while bolstering their self-esteem, social skills, and appreciation for self and peer assessment. The SMW takes place over the course of five to six weeks and involves a series of online conversations that emphasize the creative process and exploration through reflection. Artists are also offered the opportunity to sell their work on TMC's e-Gallery and showcase their work at TMC's annual Magazine Release Party & Benefit. Ultimately, teens enhance their artistic skills and develop a fully realized final product.

Service-Learning Program [SLP]: TMC's Service-Learning Program is a unique and critical part of its programming and mission. In fact, it is the only online service-learning program offered in Massachusetts. College students mentor high school artists and writers and take an active role in managing the organization. Through a comprehensive online teaching and learning model, TMC integrates meaningful community service with instruction and reflection. TMC Service-Learners assume leadership roles including: Accounting Manager, Communications Manager, Development Manager, and Editorial Mentor, among other vital roles. Through this program, young people gain access to the range of supports, opportunities and hands-on experiences, which they need to develop into skilled and thoughtful workers.
