OUT-OF-SCHOOL-TIME PROGRAM DEVELOPMENT - IS A NEW PROGRAM THAT TRAINS STAFF IN OUT-OF-SCHOOL TIME PROGRAMMING.

ALGEBRA PLUS SUMMER CAMP - AN EFFORT TO STRENGTHEN STUDENTS' UNDERSTANDING AND SKILL IN MATHEMATICS, AS A MEANS TO ADDRESS HIGH FAILURE RATES IN THIS SUBJECT.

PROFESSIONAL DEVELOPMENT - MATHPOWER'S GOAL IS TO DEVELOP A CLASSROOM CULTURE THAT ENCOURAGES STUDENTS TO THINK DEEPLY ABOUT MATHEMATICS AND TO DISCOVER FOR THEMSELVES THE RELATIONSHIPS AND STRUCTURES THAT ARE AT THE HEART OF THE DISCIPLINE. MATHPOWER'S STAFF WORKS WITH MATH TEACHERS IN THE INNER-CITY MIDDLE SCHOOLS TO CREATE THAT CULTURE.

MATHGAINS (GROW ACADEMICALLY IN NUMBER SENSE) - IS A NEW PROGRAM THAT WAS PILOTED IN 2007 - 2008. MATHGAINS IS A DIAGNOSTIC-BASED PROGRAM THAT PROVIDES INFORMATION TO TEACHERS SO THAT THEY CAN BETTER EDUCATE THEIR STUDENTS.
