We have audited the statement of financial position of Stop Handgun Violence, Inc. (a nonprofit organization) at June 30, 2010 and 2009, and the related statements of activities, functional expenses and cash flows for the years then ended. These financial statements are the responsibility of the organization's management. Our responsibility is to express an opinion on these financial statements based on our audits.

Notes to Financial Statements
June 30, 2010

Note 1 – **Organization and nature of activities**

Stop Handgun Violence, Inc. (the "Organization") is a nonprofit corporation organized to develop a public education and awareness campaign of the inherent dangers firearms and assault weapons are wreaking on our society and what can be done to help stop this senseless violence. The Organization's principal sources of revenue are grants and individual contributions.

The Organization qualifies as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code, and, therefore, has no provision for Federal income taxes. In addition, the Organization qualifies for the charitable contribution deduction under Section 170(b)(1)(A) and has been classified as an organization that is not a private foundation under Section 509(a)(1).

The Board of Directors and Management of the Organization acknowledge that to the best of their ability all assets received by the Organization have been used for the purpose for which they were contributed or have been accumulated to allow management to conduct the operations of the Organization as effectively and efficiently as possible.

Note 2 – **Summary of significant accounting policies**

Basis of presentation

The Organization's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Donated services

Some members of the Organization have donated significant amounts of time in furthering the organization's programs and objectives. No amounts have been included in the financial statements for donated member or volunteer services inasmuch as no objective basis is available to measure the value of such services.

Expense allocation

Expenses by function have been allocated among program services, fundraising and management and general classifications on the basis of direct identification and on estimates made by the Organization's management.

Statement of cash flows

For purposes of the Statement of Cash Flows, the Organization considers all highly liquid debt instruments purchased with an original maturity of three months or less to be cash equivalents.

Contributions

Contributions are recognized when the donor makes a promise to give to the Organization that is, in substance, unconditional. Contributions that are restricted by the donor are reported as increases in unrestricted net assets if the restrictions expire in the fiscal year in which the contributions are recognized. All other donor-restricted contributions are reported as increases in temporarily or permanently restricted net assets depending on the nature of the restrictions. When a restriction expires, temporarily restricted net assets are reclassified to unrestricted net assets. At June 30, 2010 and 2009, there were no restricted net assets.

In fiscal 2010, two major contributors accounted for approximately 46% of contributions. In fiscal 2009, two major contributors accounted for approximately 42% of contributions.

Grants are recorded when the Organization completes the terms of the grant contract and is entitled to payment.

Property and equipment

Property and equipment, principally a billboard, has been fully depreciated.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent events

The Organization has evaluated subsequent events through October 6, 2010 the date the financial statement were available to be issued, and determined that there were no subsequent events or transactions which could require recognition or disclosure in the financial statements.

Note 3 -- Note payable

The Organization is indebted to Citizens Bank under a \$50,000 revolving line of credit. Interest is payable monthly at a fixed rate of 6% per annum. The note is collateralized by substantially all the Organization's assets and matures on March 1, 2011.

Note 4 -- Related party transactions

Stop Handgun Violence Foundation is a nonprofit affiliate related through common control of the Organization's management and governing board. This entity had net assets of approximately \$6,486 at June 30, 2010. The Organization's main purpose is to seek legislative solutions to the issue of gun violence.

The Organization rents office space as a tenant-at-will from an affiliate of the Organization's founder. Rent expense for fiscal 2010 and 2009 was \$6,000. The Organization also reimburses this affiliate for office supplies, computer costs, photocopies and postage. An affiliate of the Organization's founder pays the payroll and benefits of the Organization's employees for which it is reimbursed. The amounts included in expenses for fiscal 2010 and 2009 were approximately \$51,000 and \$71,000 respectively.
