SCIENCE CLUBS - 543 GIRLS PARTICIPATED IN MORE THAN 45 FREE, WEEKLY HANDS-ON SCIENCE AND ENGINEERING SCIENCE CLUBS IN 18 SITES IN FIVE CITIES IN EASTERN MASSACHUSETTS (CAMBRIDGE, BOSTON, NEWTON, LAWRENCE AND FITCHBURG). THESE WERE LED BY 60-70 MENTORS EACH SEMESTER. THE AVERAGE CONTACT TIME WAS 17 HOURS PER YEAR, INCLUDING 1-1.5 HOUR LONG SCIENCE CLUBS, AN END-OF-YEAR SCIENCE SHOWCASE, AND A ZOO OVERNIGHT FOR SOME STUDENTS.

TO TEST OUR LOGIC MODEL'S PREDICTION THAT WE WILL SEE A DIFFERENCE IN GIRLS' ATTITUDES, CAREER ORIENTATION TOWARD SCIENCE AND ENGINEERING AFTER 2 YEARS' PARTICIPATION, WE SURVEYED 134 GIRLS FROM 4-6TH GRADES IN SPRING 2012. WE COMPARED GIRLS WHO HAVE HAD AT LEAST TWO YEAR'S

TEEN PROGRAMS - THE TEEN PROGRAMS EXPANDED IN NUMBER OF PARTICIPANTS AND STEM PROGRAMS THIS LAST YEAR. THE GIRLS ALSO HAD SIGNIFICANT ACHIEVEMENTS. THE HIGH SCHOOL ROCKET TEAM WAS ONLY ONE OF THREE TEAMS IN NEW ENGLAND, AND ONE OF FEWER THAN TEN ALL-GIRLS TEAM IN THE COUNTRY TO QUALIFY FOR THE NATIONAL TEAM AMERICA ROCKETRY CHALLENGE. THE YOUNG WOMEN DESIGNED AND BUILT THEIR OWN ROCKETS, AND TRAVELLED TO VIRGINIA TO PARTICIPATE IN THE FINALS.

WE CREATED A SUMMER CAREER EXPLORATION PROGRAM, WHERE GIRLS INVESTIGATED AND LEARNED ABOUT A DIFFERENT STEM INDUSTRY EACH WEEK. DURING THE SCHOOL YEAR, WE PILOTED TWO NEW TECHNOLOGY PROGRAMS: A MOBILE APP PROGRAMMING FOR HIGH SCHOOL GIRLS WHO HAD LITTLE PREVIOUS

SPECIAL PROGRAMS SERVED OVER 277 GIRLS. THESE ARE TYPICALLY WEEK-LONG OR FULL DAY PROGRAMS THAT COMBINE FIELD TRIPS AND HANDS-ON OPPORTUNITIES THAT WE ARE TYPICALLY UNABLE TO OFFER DURING THE SCHOOL YEAR PROGRAMS. 50 SECOND TO SIXTH GRADE GIRLS EXPLORED GREEN CHEMISTRY, ECOLOGY AND ZEBRAFISH BIOLOGY THROUGH TWO VACATION WEEK PROGRAMS, WHILE ANOTHER 47 MIDDLE SCHOOL GIRLS EXPLORED ENGINEERING AS WELL AS COMPUTER TECHNOLOGY THROUGH TWO TECHSAVVY PROGRAMS. ONE-TIME OUTREACH EVENTS INCLUDED SHOW ME THE SCIENCE, ATTRACTING OVER 60 BOSTON AREA STUDENTS AND THEIR FAMILIES, AND THE ONE-DAY SET IN THE CITY CAREER EXPLORATION EVENT HELD IN COLLABORATION WITH THE BOSTON AREA GIRLS STEM COLLABORATIVE, THAT ATTRACTED OVER 120 HIGH SCHOOL GIRLS FROM GREATER BOSTON AND BEYOND.
