SCIENCE CLUBS: 607 GIRLS PARTICIPATED IN FREE, WEEKLY HANDS-ON SCIENCE AND ENGINEERING SCIENCE CLUBS IN EASTERN MASSACHUSETTS (CAMBRIDGE, BOSTON, NEWTON, LAWRENCE AND FITCHBURG). 76% OF THESE GIRLS WHO PARTICIPATED IN THE FALL SEMESTER RETURNED FOR THE SPRING SEMESTER. THE AVERAGE CONTACT TIME WAS 17 HOURS PER YEAR, INCLUDING HOUR-LONG SCIENCE CLUBS, AN END-OF-YEAR SCIENCE SHOWCASE, AND A MUSEUM OVERNIGHT PROGRAM.
