SCIENCE CLUBS - A TOTAL OF 65 SCHOOL-YEAR K-8 SCIENCE CLUBS ENGAGED 794 PARTICIPANTS AT 14 SITES IN FIVE CITIES IN EASTERN MASSACHUSETTS (CAMBRIDGE, BOSTON, NEWTON, LAWRENCE AND FITCHBURG). CLUBS WERE LED BY VOLUNTEER MENTORS AT A RATIO OF APPROXIMATELY 1 ADULT:5 GIRLS EACH SEMESTER. CLUBS MET FOR 1-1.5 HOURS PER WEEK FOR 8-10 WEEKS IN THE FALL AND SPRING.
