K-5 PROGRAMMING: CONSISTS OF "SCIENCE CLUBS" THAT MEET IN THE OUT-OF-SCHOOL TIME SETTING FOR 1-HOUR PER WEEK FOR 8-10 WEEKS PER SEMESTER DURING THE ACADEMIC YEAR. OUR PROGRAMS ARE SUPPORTED BY PAID STAFF, BUT LED BY 148 VOLUNTEER MENTOR SCIENTISTS AND 87 HIGH SCHOOL AGED JUNIOR MENTORS, ESTABLISHING A RESEARCH BASED NEAR-PEER MENTORING NETWORK TO SUPPORT YOUNG GIRLS' EXPLORATION OF STEM TOPICS AND DEVELOPMENT OF THEIR PERSONAL STEM IDENTITY. IN FY15, WE ENGAGED 703 GIRLS IN GRADES K TO 5 ACROSS 10 LOCATIONS AND 62 CLUB PROGRAMS SERVING BOSTON, CAMBRIDGE, NEWTON AND LAWRENCE. 77% WERE GIRLS OF COLOR AND/OR FROM LOWER INCOME FAMILIES. PROGRAM TOPICS COVER A WIDE VARIETY OF STEM SUBJECTS THROUGH INTERACTIVE HANDS-ON ACTIVITIES AND ENGAGEMENT WITH VOLUNTEER STEM PROFESSIONALS WHO ADD THEIR PERSONAL PASSION AND

TEEN PROGRAMMING: SCIENCE CLUB FOR GIRLS' TEEN PROGRAM SUPPORTS YOUNG WOMEN IN GRADES 8 TO 12 THROUGH A VARIETY OF PATHWAYS. WE EXPANDED OUR NEW MIDDLE SCHOOL PATHWAY, STEMINISTAS, FROM 2 SITES LAST YEAR TO 4 THIS YEAR AND TRIPLING ENGAGEMENTS TO 92 GIRLS, WITH 76% OF WHOM ARE OF COLOR AND/OR FROM LOWER INCOME FAMILIES. GROUNDED IN THE ENGINEERING DESIGN PROCESS, THIS PROGRAM ENCOURAGES PARTICIPANTS' PROBLEM SOLVING AND CREATIVE THINKING BY PROVIDING THEM WITH A NUMBER OF SHORT CHALLENGES TO SOLVE OVER THE COURSE OF THE YEAR. GIRLS HAVE EXPLORED BUILDING STRUCTURES TO SURVIVE NATURAL DISASTERS, USED ELECTRONIC COMPONENTS TO CREATE ROBOTS TO MAKE ART, AND EXPLORED LIFE IN EXTREME ENVIRONMENTS LIKE THE DEEP SEA AND SPACE. OUR HIGH SCHOOL CHALLENGE TEAMS ALLOWED YOUNG WOMEN TO EXPLORE STEM CONCEPTS SUCH AS ROCKETRY AND

COMPRISED PREDOMINANTLY OF WOMEN WHO ARE STUDYING OR WORKING IN A STEM FIELD, OUR VOLUNTEER MENTORS LEAD OUR WEEKLY CLUB PROGRAMS, SERVE AS WORKSHOP SPEAKERS, HELP DEVELOP AND REVISE CURRICULUM, AND LEAD FIELD TRIPS.
