IN 2014, AN ESTIMATED 450 INDIVIDUALS AND/OR FAMILIES WERE SERVED OVER 57,000 LBS OF PRODUCE, AND OVER 30 GALLONS OF MAPLE SYRUP. DISTRIBUTION TO THE VARIOUS GROUPS, WHO THEN DISTRIBUTE IT TO INDIVIDUALS, BEGINS IN APRIL AND CONTINUES INTO NOVEMBER.
