THE FOOD ASSISTANCE PROGRAMS PROVIDE EMERGENCY FOOD TO THOSE IN NEED THROUGH A PANTRY VISIT OR DELIVERY MONDAY THROUGH FRIDAY AND TWO SATURDAYS PER MONTH. DURING FY16, THE FOOD PANTRY SERVED 2,522 INDIVIDUALS (1,111 HOUSEHOLDS) WITH 307,720 LBS OF FOOD DISTRIBUTED IN 7693 VISITS. DURING FY16, THE MOBILE MARKET SERVED 860 INDIVIDUALS (520 HOUSEHOLDS) WITH 52,934 LBS. OF FOOD. THE SUMMER FOOD PROGRAM DISTRIBUTED 8,469 LBS OF FOOD TO 283 INDIVIDUALS (94 HOUSEHOLDS) IN 286 VISITS TO FAMILIES IN NEED OF EXTRA FOOD DURING THE SUMMER MONTHS.
