SUMMER FUND - A 45 YEAR OLD DONOR COLLABORATIVE SUPPORTING SUMMER CAMPS AND PROGRAMS FOR DISADVANTAGED AND AT-RISK YOUTH COMMUNITIES IN GREATER BOSTON. THE SUMMER FUND SUPPORTED 75 NONPROFITS OPERATING OVER 100 SUMMER CAMP AND PROGRAM SITES. IN 2015 OVER 20,000 YOUTHS ATTENDED THESE SUMMER CAMPS AND PROGRAMS. AGM PARTNERED WITH 25 ARTS, CULTURAL AND HISTORICAL ASSOCIATIONS TO GIVE 10,000 YOUTHS FREE FIELD TRIPS THROUGH CULTURAL DAY EVENTS. THE HOMELESS CAMPSHIP FUND, TARGETING FAMILIES IN HOMELESS SHELTERS AND THOSE FACING HOUSING SHORTAGES, SUPPORTED OVER 650 WEEKS OF FREE SUMMER CAMP SLOTS. THE TEEN LEADERSHIP INSTITUTE TRAINED AND PLACED OVER 180 HIGH SCHOOL STUDENTS IN A SUMMER JOB OPPORTUNITY AT A SUMMER FUND CAMP OR YOUTH SERVING NONPROFIT.
