**Engagement - We believe poverty is the root cause of violence and MJE is focused on educating individuals who are victims of violence to set financial goals and improve their financial future. The Financial Education program is designed to help low-income individuals understand the importance of establishing realistic timely financial goals.**

**- In 2015 MJE won a 3-year contract with the Suffolk County House of Corrections to provide Financial Education Coaching to 200 male and female inmates annually; a re-entry initiative to reduce recidivism in Suffolk County.**

**- 100% of the house of correction inmates will successfully develop a financial plan before re-entering the community.**
