For this program, Science from Scientists has designed hands-on, activity-based modules in STEM (science, technology, engineering, and mathematics) complementary to regular school curricula. Modules incorporate national and state standards and have been designed to contain a lecture segment and a hands-on laboratory segment. We have developed modules in biology, chemistry, earth science, and physics on many topics the students would not yet typically see at school. Our staff members go into the schools during the school day - or in after-school programs in the case of some partnerships - and teach our modules to students in grades 4-8.
