In 2013, NSIV joined with four local colleges to create the Life Sciences Consortium of the North Shore and in September applied for a Mass Life Sciences Center capital equipment grant which was awarded in March 2014, though funds were not received in this fiscal year. There were 13 companies in our Biotech Incubation Program by the end of June 2014 and four had graduated. Approximately 69 people were employed by the 13 members and 28 by the graduates. Expenses grew significantly due to the costs associated with operating the laboratory but program revenues kept pace to cover operating costs. Pro bono support from corporate sponsors and volunteer mentors was critical to the success of the program.

4b (Code:) (Expenses \$ 155,296. including grants of \$) (Revenue \$ 96,361.) The Cleantech Incubation Program grew to seven companies during the fiscal year, employing approximately 36 people and there have been seven graduates, employing 58 people. One cleantech company was utilizing the 1100 sq ft cleantech laboratory. Most of the startups in the Cleantech Program either only use office space or are virtual members utilizing services but no dedicated space.
