4a (Code:) (Expenses \$ 507,212. including grants of \$) (Revenue \$ 461,710.) In FY 2016 NSIV continued to grow and acquire resources to support its biomedical startups. NSIV added 600 sq ft of lab space and outfitted it through a grant from the Mass Life Sciences Center, including the purchase of an ultra-low temperature freezer, spectrophotometer, balances, incubators, and a PCR system. There were 18 companies in our Biotech Incubation Program by the end of June, 2016, and seven had graduated (Three companies withdrew and are not counted). Approximately 110 people were employed by the 18 member companies and 71 by the graduates for a total of 181 jobs created since the start of the program. The biotech companies in the incubator also trained eight interns. With the addition of space and equipment, expenses grew but revenues kept pace, covering operating costs. No grants were provided

4b (Code:) (Expenses \$ 181,996. including grants of \$) (Revenue \$ 50,435.) The Cleantech Incubation Program supported seven companies during the fiscal year, one of which graduated during that year for a total of eight graduates by year end. At the close of FY 2016 the six cleantech companies in the incubator employed 36 people and trained two interns and the eight cleantech graduates employed 59 people for a total of 95 jobs created since the start of the program. Collectively the cleantech companies have obtained twelve SBIR grants. Two of the cleantech companies in the program used office space in the incubator routinely; the others are in the virtual incubation program and come in for progress reviews. Corporate sponsors and a grant from the Mass Clean Energy Center to NSIV were especially important to maintaining revenues in balance with expenses. No grants were provided by NSIV.
