IN 2008, WOMEN OF MEANS DOCUMENTED 9972 INDIVIDUAL CLINICAL ENCOUNTERS AT 10 DIFFERENT HOMELESS SHELTER SITES. THE ORGANIZATION USED 17 VOLUNTEER DOCTORS, 2 VOLUNTEER NURSES AND 7 PART-TIME SALARIED NURSE CASE MANAGERS. THE CLINICAL STAFF ALSO SUPERVISED APPROXIMATELY 100 MEDICAL AND NURSING STUDENTS AND MEDICAL RESIDENTS WHO HAD AGREED TO PERFORM COMMUNITY SERVICE WITH THE ORGANIZATION. AS AN INDICATION OF HOW WE ADVOCATE FOR THE WOMEN WHEN THEY NEED TO USE THE HEALTHCARE SYSTEM, WOMEN OF MEANS STAFF MADE 2156 CLINICAL COMMUNICATIONS AND REFERRALS ON BEHALF OF THE WOMEN AND THEIR CHILDREN DURING THE YEAR.
