AFC HAS EXPANDED OUR STAFF TEAM, ENGAGED IN STRATEGIC PLANNING, AND IMPLEMENTED PROGRAMMATIC CHANGES TO BETTER SERVE YOUTH. THE AFC MENTORS PROGRAM CONTINUED TO SUPPORT LONG-TERM RELATIONSHIPS FOR YOUTH IN FOSTER CARE. THIS YEAR, AFC INCREASED OUR AVERAGE MENTORING MATCH LENGTH TO OVER 26 MONTHS, GREATLY SURPASSING THE NATIONAL AVERAGE OF ONLY NINE MONTHS. IN 2012, AFC SERVED 159 BOSTON-AREA YOUTH AND YOUNG ADULTS THROUGH ONE-TO-ONE MENTORING RELATIONSHIPS, LIFE-SKILLS WORKSHOPS, INTERNSHIPS, AND COMMUNITY ACTIVITIES. 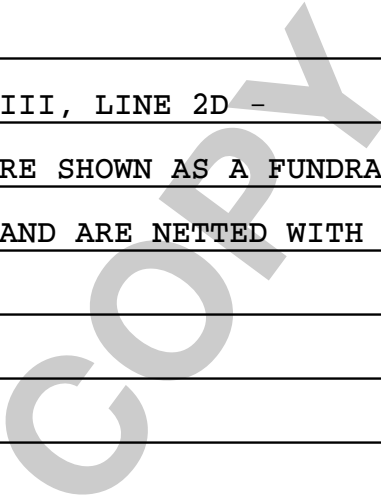
