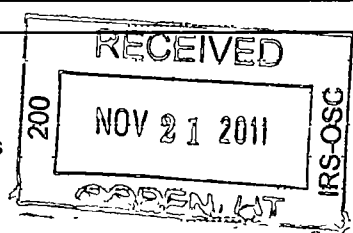

STRATEGIES FOR YOUTH IS DEDICATED TO IMPROVING THE INTERACTIONS BETWEEN POLICE AND YOUTH BY INCREASING THE APPROACH, OPTIONS, AND RESPONSES OF POLICE TO YOUTH. THROUGH TRAINING THAT INTGEGRATES DEVELOPMENTAL AND PSYCHIATRIC PRACTICES AND CUTTING EDGE RESEARCH, AND DEVELOPING LEADERSHIP IN POLICE DEPARTMENTS, STRATEGIES FOR YOUTH AIMS TO REFRAME WHAT IS TOO OFTEN AND ADVERSARIAL APPROACH TO POLICE/YOUTH RELATIONS.
