**Description Part III, 4a Group Home**

Plummer Home applies an Intervention Model we call "Permanency, Preparedness, Community" in all of our programs. The model posits that all children need families, skills and connections with their communities to succeed as adults. Skills and connections are ideally built with the help of a family. Our work focuses heavily on making sure that youth who have been removed from their families make it back to their family, or a new, permanent family, as soon as possible. This element of our work has drawn a great deal of attention from others, and we have started to consult and/or train other organizations.

Our group home serves young men ages 13-18 referred by the Department of Children and Families. Capacity is 12 youth, and we serve approximately 25 per year as youth move in and out during the year. Most of our young people were removed from their homes at a young age due to issues of abuse or neglect and have been bouncing around the state's child welfare system. It is not uncommon for our youth to have been moved more than 10 or 20 times, bouncing between placements such as group homes, foster homes and hospitals. Many of our youth struggle with issues such as Post Traumatic Stress, Depression, Anxiety and Attention Challenges. All are in need of a family who will commit to them forever.

We recently implemented a system to measure each youth's progress in the areas of Permanency, Preparedness and Community. The system documents progress along scale of 1-4; observable benchmarks must be reached to progress along the scale. Assessing progress includes the use of both evidence-based tools and subjective observations.

**Description Part III, 4b Foster Care**

The Permanency, Preparedness Community Intervention Model described in the section above on our Group Home is also used in our Foster Care Program. Though the Foster Care program is licensed to serve children from birth to age 22, we specialize in working with older children. As in our other programs, we place paramount importance on stopping youth from bouncing around the foster care system and connecting them with a family that is committed to them forever. We recruit and train foster families who believe in our goal, and they become part of the team to find the child a permanent family. In some cases, they become the permanent family while in others they are simply the bridge to a permanent family. The measurement system described in the Group Home section above will be expanded into our Foster Care program soon.

The Foster Care program currently serves about 20 children a year. Demand for the program is extraordinary, and in calendar year we had to turn away approximately 700 referrals due to lack of available foster families. For that reason, we are aggressively recruiting foster parents.

## **Description Part III, 4c Practice Leadership**

### **Permanency**

Each year in MA, approximately 1,000 youth leave foster care without a permanent family; nationally, the number is about 25,000. This is called aging out of care. Research in MA and around the country documents staggering negative outcomes for such youth.

Plummer Home is working to change those outcomes by helping youth achieve permanency - safe, stable and lifelong family relationships. We do this using the following four tools:

**Family Search and Engagement:** We find and engage parents and family members to decrease youths' loneliness, strengthen their sense of identity and belonging, increase their family network and develop a safe, permanent parenting relationship. When there is no biological family able to provide that relationship, we recruit new families.

**Permanency Preparation and Readiness:** Because older youth in care often have moved around for years, they may be confused about their personal history and may have internalized the idea that life is a series of temporary stops. We help them clarify their past and prepare to be part of a lifelong family. At the same time, we prepare families to parent and/or have sustained relationships with children who have experienced trauma. We help them understand challenging behaviors that stem from the youth's life experience so they can help the youth heal and commit to them unconditionally.

**Collaborative Problem-Solving,** an evidence-based practice for working with difficult behaviors. This practice is based on the understanding that challenges posed by youth in care result from lagging cognitive skills (rather than poor motivation, manipulation, or attention-seeking) and are best addressed by teaching youth the skills they lack (rather than imposing punishment or a reward system). We use this every day.

**Youth-Guided Teaming:** We build a team around each youth, allowing him or her to actively guide planning for family relationships and their future. Teams include parents, relatives and other caring adults as well as professionals. Our teaming approach addresses all areas of youth safety, permanency and well-being and aims to build a network of lifelong relationships that continue after the youth exits the system.

## **Description Part III, 4d: Supported Apartment Program (Independent Living)**

Like in our Group Home, we apply our Permanency, Preparedness, Community Intervention Model (see description above) in our Supported Apartment program. Our Supported Apartment serves young men between the ages of 16 and 22. The apartment is in the same building as our Group Home but is in a physically separate part of the building. Young men living in the apartment must be in school or working, and are responsible for things like cooking, grocery shopping, laundry and cleaning. In the Supported Apartment we have implemented the same measurement system described above in the Group Home description.

### **Description Part III, 4d: Community Apartment Program (Pyramid Program)**

Our community apartment program uses the same Intervention Model described in the section above on our Group Home. The Community Apartment program serves young men and women ages 18- 22 who turned 18 while in the foster care system and now have no place to live. The Community Apartment program is a series of one-bedroom apartments in a variety of communities. The number of apartments goes up and down depending on the number of youth referred to the program. The measurement system that has been implemented in the Group Home and Supported Apartment is also used in the Community Apartment program.

### **Description Part III, 4d: On Point**

On Point is a collaboration among Plummer Home, the Salem Police and Essex County Juvenile Probation. The goal is to keep young people living with their families by helping them get out of and/or stay out of trouble. It is located in one of Salem most volatile neighborhoods, and operates during non-school hours. Activities include group therapy, education and recreation. One of On Point's primary goals is to keep youth out of locked detention. Of those youth who have been ordered by the Court into the On Point program since 2011, 82% remain free of detention one-year after completing the program.
