RESOLVED: That the Corporation shall formalize the current process by which low-income program beneficiaries advise the Corporation in all of its decisions regarding the design, siting, development, and management of affordable housing projects. To implement this objective, the Executive Director shall furnish to the Board of Directors a general written statement of operating procedures, and, for each such affordable housing project, a customized plan of community outreach/consultation and a detailed report and record of the input, advice, and results obtained from such outreach efforts.

RESOLVED FURTHER, that the officers of the Corporation, acting singly or together, are authorized and directed to execute such documents and take such further actions as may be necessary or advisable to carry out the purposes of the foregoing resolution, including the filing of this Unanimous Written Consent with the records of the meetings of the directors of the Corporation.
