The Fund served 1648 low income homeowners and grassroots nonprofit organizations by providing building materials at approximately 25% of fair market value. Income from sales of materials was \$522,081. We accepted donated building materials with a fair market value of \$1,941,557 in 2014. Donations came from 1,606 homeowners, contractors, retailers, and manufacturers.

The Fund's workshops teach skills homeowners can use to make improvements and repairs to their homes. Taught by professional contractors, workshops cover topics such as window repair, making doors work, tiling, home weatherization, and drywall installation. Customers can receive answers to their home repair questions over the phone, at the store, or through home visits.
