The Fund served 2,065 low income homeowners and grassroots nonprofit organizations by providing building materials at approximately 25% of fair market value. We accepted donated building materials with a fair market value of \$2,065,910 in 2016. Donations came from 1,702 homeowners, contractors, retailers, and manufacturers.

The Fund's workshops teach skills homeowners can use to make improvements and repairs to their homes. Taught by professional contractors, workshops cover topics such as window repair, making doors work, tiling, home weatherization, and drywall installation. Customers can receive answers to their home repair questions over the phone, at the store, or through home visits. The Fund's window and screen repair clinic offers hands-on instruction on the repair of broken windows and torn screens.
