INDIVIDUAL DEVELOPMENT ACCOUNT (IDA) PROGRAM. IN FY09, COMPASS LAUNCHED A NEW INDIVIDUAL DEVELOPMENT ACCOUNT (IDA) PROGRAM IN BROOKLINE AND EXPANDED ITS EXISTING PROGRAMS IN LYNN AND IN BOSTON. THE PROGRAM PROVIDES FINANCIAL EDUCATION, COACHING, AND MATCHED SAVINGS ACCOUNTS FOR WORKING, LOW-INCOME FAMILIES TO HELP THEM SAVE TOWARD A FIRST-TIME HOME, A COLLEGE EDUCATION, OR A SMALL BUSINESS. IN FY09, COMPASS ENROLLED A TOTAL OF 44 PARTICIPANTS IN THE IDA PROGRAM. IN ADDITION, DURING FY09, 16 FAMILIES GRADUATED FROM THE IDA PROGRAM AND INVESTED IN ASSET PURCHASES. IN FY09, COMPASS ALSO LAUNCHED A NEW INITIATIVE TO HELP LOW-INCOME FAMILIES SAVE FOR COLLEGE. COMPASS IMPLEMENTED TWO "PLANNING AND SAVING FOR COLLEGE" EVENTS, ONE IN BOSTON AND ONE IN BROOKLINE. THROUGH THESE EVENTS, COMPASS HELPED OPEN 45 COLLEGE SAVINGS ACCOUNTS FOR LOW-INCOME FAMILIES.

TO PROMOTE ECONOMIC SECURITY FOR WORKING, LOW-INCOME FAMILIES BY PROVIDING INNOVATIVE FINANCIAL PRODUCTS AND SERVICES THAT HELP PEOPLE BUILD WEALTH AND KNOWLEDGE.
