THE CENTER PROVIDES A HOLLISTIC DAY PROGRAM CONSISTING OF NURSING CARE, THERAPEUTIC ACTIVITIES, MEALS, SOCIAL SERVICES AND TRANSPORTATION. THE CENTER PROVIDED 15,508 UNITS (DAYS) OF CARE TO AN AVERAGE OF 61 ADULTS A DAY.
