We seek to develop young women with a strong sense of self-confidence and esteem for themselves and others and instill leadership qualities which will enable them later in life to serve the needs of their broader communities. During the mandatory after-school program, students engage in a variety of activities such as sports, art, and cooking. The evening study program helps students complete homework assignments and/or provides tutoring. Graduate support is provided. 100% of our girls graduate from high school and 95% graduate from college.

4b (Code: ) (Expenses \$ 265,748. including grants of \$ ) (Revenue \$ 35,666.) The ADULT EDUCATION program enrolls over 150 students per semester. Morning and evening classes are offered in computer and basic literacy and five levels of English to Speakers of Other Languages. In addition to formal classes, workshops are offered in such topics as citizenship, resume writing, and banking.

4c (Code: ) (Expenses \$ 97,273. including grants of \$ ) (Revenue \$ 11,471.) The SHINING STAR AFTER-SCHOOL program provides 3rd & 4th grade boys and girls with the skills and academic strength they will need to qualify for competitive middle schools. The after-school sessions offer enrichment in the areas of reading, writing, math, and study skills, in addition to fostering the moral development and leadership potential of each student through character development.
