During the mandatory after-school program, students engage in a variety of activities such as sports, art, and cooking. The evening study program helps students complete homework assignments and/or provides tutoring. Graduate support is provided. 100% of our girls graduate from high school and 95% graduate from college.

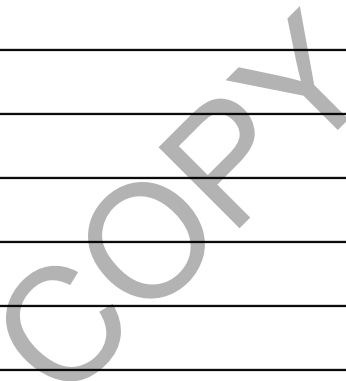

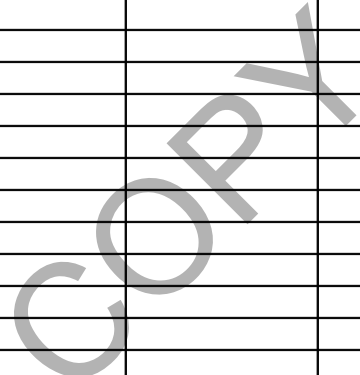
