THE VAST MAJORITY HAVE BEEN INCARCERATED, AND HAVE BECOME TRAPPED IN A CYCLE OF CRIME AND VIOLENCE SPURRED ON BY EXTREME POVERTY, SEGREGATION AND ISOLATION.
