THE VAST MAJORITY HAVE BEEN INCARCERATED, AND HAVE BECOME TRAPPED IN A CYCLE OF CRIME AND VIOLENCE SPURRED ON BY EXTREME POVERTY, SEGREGATION AND ISOLATION. BY REACHING THE FEW, AND PROVIDING THEM WITH A LOGICAL ALTERNATIVE TO THE STREETS, WE CAN CREATE A RIPPLE EFFECT THAT IMPACTS THE LIVES OF MILLIONS OF PEOPLE LIVING IN OUR URBAN COMMUNITIES.
