- 5/20 Fulfill prisoners' requests for educational, self-help, research, spiritual, and other books donated to the Prison Book Program, Quincy
The all-volunteer Prison Book Program strives to provide prisoners across the country with free, quality reading materials to expand their minds beyond the walls that cage them, to change their own lives, and to speak out for their rights.
- 5/24 Collate Braille-embossed, translucent, plastic pages between printed pages of *Rosie Revere, Engineer* children's books for the National Braille Press, Boston
The guiding purposes of the National Braille Press are to promote the literacy of blind children in North America through Braille and to enable blind people to better participate in work, family, and civic affairs through information. Children's print-Braille books enable sighted and blind children and adults to read together. These special books are sold for the same prices as printed books are sold to sighted people, so our volunteers' sponsorship donations and labor make up the cost difference.
