DREAM FLYERS: THE DREAM FLYERS PROGRAM IS A SPECIAL WAY TO BRING JOY AND HOPE TO SERIOUSLY ILL, DISABLED AND UNDERPRIVILEGED CHILDREN. MANY EXISTING IN-HOSPITAL PROGRAMS ARE DESIGNED TO ALLEVIATE THE TEDIUM OF LONG HOSPITAL STAYS AND DIFFICULT MEDICAL TREATMENTS AND PROCEDURES. ABOVE THE CLOUDS COMPLEMENTS THESE ACTIVITIES WITH A DIFFERENT APPROACH THAT DELIVERS A UNIQUE KIND OF MEDICINE PROGRAMMING DESIGNED TO BUILD ANTICIPATION AND EXCITEMENT FOR A SPECIAL, JOYFUL EXPERIENCE FLYING IN THE CO-PILOTS SEAT OF A SMALL AIRPLANE. CADET FLYERS: THE CADET FLYERS PROGRAM IS A DIRECT RESPONSE TO THE GROWING NUMBER OF YOUNG PEOPLE WHO ARE EITHER FALLING THROUGH THE CRACKS AT SCHOOL OR ARE INVOLVED WITH SOCIAL SERVICE AGENCIES DUE TO POVERTY ISSUES OR DIFFICULT HOME SITUATIONS. THE DROP-OUT RATE IN THE BOSTON PUBLIC SCHOOLS, FOR EXAMPLE, IS 34.1%.
