MANY EXISTING IN-HOSPITAL PROGRAMS ARE DESIGNED TO ALLEVIATE THE TEDIUM OF LONG HOSPITAL STAYS AND DIFFICULT MEDICAL TREATMENTS AND PROCEDURES. ABOVE THE CLOUDS COMPLEMENTS THESE ACTIVITIES WITH A DIFFERENT APPROACH THAT DELIVERS A UNIQUE KIND OF MEDICINE O PROGRAMMING DESIGNED TO BUILD ANTICIPATION AND EXCITEMENT FOR A SPECIAL, JOYFUL EXPERIENCE FLYING IN THE CO-PILOT'S SEAT OF A SMALL AIRPLANE.
