THE GOAL OF THIS INITIATIVE IS TO DECREASE THAT EROSION OF LEARNING AND TO CLOSE THE OPPORTUNITY GAP BETWEEN LOW-INCOME STUDENTS AND THEIR HIGHER-INCOME PEERS. THE PROGRAM CONNECTS SCHOOLS WITH COMMUNITY ORGANIZATIONS THAT PROVIDE EDUCATIONAL EXPERIENCES AND PROVIDES GRANTS TO EXECUTE THESE SUMMER LEARNING PROGRAMS.
