OUR COMMUNITY CHILDREN'S CENTERS BEGAN IN BOSTON IN 1994 AND PROVIDE COMPREHENSIVE EARLY EDUCATION SERVICES SPECIFICALLY FOCUSED ON THE NEEDS OF YOUNG HOMELESS CHILDREN, AGES TWO MONTHS THROUGH FIVE YEARS, WHILE PROVIDING PARENTS WITH SUPPORT SERVICES AND RESOURCES TO BREAK THE CYCLE OF HOMELESSNESS AND BECOME SELF-SUFFICIENT. WE OPERATE 3 SUCH CENTERS SERVING A TOTAL OF 175 CHILDREN EACH WEEKDAY FROM 8AM TO 6PM. SINCE THE PROGRAM BEGAN IN 1994, WE HAVE SERVED MORE THAN 1,000 HOMELESS CHILDREN AND THEIR FAMILIES AND HELPED THEM MOVE INTO SELF-SUFFICIENCY.

THE PLAYSPACE PROGRAM HAS BEEN PROVIDING GREATER BOSTON FAMILY HOMELESS SHELTERS WITH PLAYSPACES AND VOLUNTEERS (CALLED PLAYSPACE ACTIVITY LEADERS OR PALS) SINCE 1990, AND HAS EXPANDED TO PROVIDE THESE SERVICES TO CHILDREN IN FAMILY SHELTERS THROUGHOUT MASSACHUSETTS. TRAINED VOLUNTEERS ENGAGE CHILDREN IN EDUCATIONAL ACTIVITIES, GIVING EACH CHILD AN OPPORTUNITY TO LEARN AND GROW FROM THESE INTERACTIONS, AS WELL AS HAVE FUN. SINCE 1990 MORE THAN 11,000 VOLUNTEERS HAVE SERVED FOR AT LEAST 6 MONTHS FOR 2 HOURS PER WEEK, AND IN FY14 WE REACHED A PEAK OF 2,120 PALS PER WEEK IN 152 SHELTERS FOR HOMELESS CHILDREN ACROSS THE STATE. THE ESTIMATED VALUE OF THESE VOLUNTEERS WAS \$4,050,000 IN FY 2014.
