CHILDREN'S CENTER - THE CHILDREN'S CENTER IS A NATIONAL ASSOCIATION FOR THE EDUCATION OF YOUNG CHILDREN (AKA NAEYC) ACCREDITED EARLY CHILDHOOD EDUCATION AND CHILD CARE FACILITY, PROVIDING CHILDREN WITH FULL TIME, YEAR-ROUND CARE. THE CHILDREN'S CENTER IS LICENSED BY THE MASSACHUSETTS DEPARTMENT OF EARLY EDUCATION AND CARE (EEC) AND ACCEPTS CHILDREN FROM 1 MONTH THROUGH 5 YEARS OF AGE. THE STATIC OPERATING CAPACITY FOR FY 2012 WAS 50 CHILDREN. DURING FY2012 THE CHILDREN'S CENTER PROVIDED SERVICES TO 82 CHILDREN. FOOD PANTRY - THE FOOD PANTRY PROVIDES FOOD TO INDIVIDUALS AND FAMILIES WITHOUT ADEQUATE FINANCIAL RESOURCES TO MEET BASIC NEEDS. DURING FY2012, THE FOOD PANTRY PROVIDED FOOD TO 2,163 UNDUPLICATED INDIVIDUALS. RECIPIENTS HAVE REPORTED THAT THE QUANTITY OF FOOD THEY RECEIVE GENERALLY LASTS ABOUT 4 TO 5 DAYS. USE OF THE FOOD PANTRY IS LIMITED TO ONE TIME PER MONTH. THE FOOD PANTRY IS OPEN TO ALL HOUSEHOLDS, BY APPOINTMENT ONLY, ON TUESDAYS AND THURSDAYS, 9:45 AM TO 12 PM AND 1:30PM TO 3PM. TO HELP CLIENTS AT THANKSGIVING AND CHRISTMAS, FOOD PANTRY STAFF AND VOLUNTEERS DISTRIBUTE SPECIAL HOLIDAY FOOD BASKETS. A COMMUNITY RESOURCE COORDINATOR IS AVAILABLE TO FOOD PANTRY CLIENTS,
