THE CHILDREN'S CENTER IS LICENSED BY THE MASSACHUSETTS DEPARTMENT OF EARLY EDUCATION AND CARE (EEC) AND ACCEPTS CHILDREN FROM 1 MONTH THROUGH 5 YEARS OF AGE.
