1) OVERNIGHT SHELTER: 9 BED SHELTER PROVIDES HOMELESS WOMEN AND CHILDREN WITH SAFE SHELTER AND FOCUSES ON HELPING EACH WOMAN PUT TOGETHER A PLAN TO ADDRESS HER IMMEDIATE NEEDS AND SECURE PERMANENT HOUSING.

2) SUPPORTING HOUSING: 70 SINGLE ROOM OCCUPANCY HOUSING UNITS FOR WOMEN IN 2 BUILDINGS AND 7 TWO BEDROOM APARTMENTS FOR WOMEN AND CHILDREN IN ANOTHER BUILDING ARE DESIGNED TO MEET THE NEEDS OF WOMEN WHO CANNOT AFFORD MARKET-RATE RENT. EACH WOMAN IS ASSIGNED AN ADVOCATE TO HELP IDENTIFY REALISTIC GOALS AND TO CONNECT TO INFORMATION AND RESOURCES.
