THE BOSTON TEACHER RESIDENCY (BTR) PROGRAM IS PART OF BOSTON'S STRATEGY TO IMPROVE INSTRUCTION FOR EVERY CHILD. BTR RECRUITS TALENTED, COMMITTED PEOPLE TO MAKE A DIFFERENCE IN THE CITY'S CLASSROOMS. DURING THE 13-MONTH PROGRAM, TEACHER RESIDENTS WORK SIDE-BY-SIDE WITH MENTOR TEACHERS IN BOSTON'S PUBLIC SCHOOLS AND TAKE A SPECIALIZED CURRICULUM DEVELOPED AND LED BY LOCAL EDUCATORS AND COMMUNITY LEADERS.
