DURING THE 13-MONTH PROGRAM, TEACHER RESIDENTS WORK SIDE-BY-SIDE WITH MENTOR TEACHERS IN BOSTON'S PUBLIC SCHOOLS AND TAKE A SPECIALIZED CURRICULUM DEVELOPED AND LED BY LOCAL EDUCATORS AND COMMUNITY LEADERS.
