IN THE FIRST 6 MONTHS OF 2014, FOOD FOR FREE DISTRIBUTED OVER 580,000 POUNDS FOOD TO OVER 90 EMERGENCY FOOD PROGRAMS IN BOSTON, CAMBRIDGE, CHELSEA, LYNN, MEDFORD, PEABODY, SOMERVILLE AND WATERTOWN. FOOD FOR FREE ALSO WORKED WITH THE GREATER BOSTON FOOD BANK IN 2013 DELIVER 858,000 POUNDS OF FOOD TO 12 EMERGENCY FOOD PROGRAMS.
