AFC MENTORS, THE ORGANIZATION'S ONE-TO-ONE MENTORING PROGRAM, MATCHES YOUTH (AGES 7 AND OLDER) WITH CARING, CONSISTENT ADULT VOLUNTEERS. THE AFC MENTORS "MATCHES" COMMIT TO AT LEAST ONE YEAR OF MENTORING, HOWEVER, MOST MATCHES LAST SIGNIFICANTLY LONGER.
